Dear Commissioner

Re: Progressing animal welfare and ethics in the International Whaling Commission

We write to bring to your attention the newly released report of the 'Whale Welfare and Ethics Workshop' and, in particular, to urge you to support the recommendations of the Workshop at the 63rd meeting of the IWC in July.

The United Kingdom's proposal for the Workshop, at IWC62, was welcomed and encouraged by many contracting governments. The Workshop was subsequently held in March and the report, submitted by the UK, is now available at:

http://iwcoffice.org/ documents/commission/IWC63docs/63-WKM&AWI4.pdf

The Workshop brought together over 30 international experts in the fields of animal welfare, ethics, and marine mammals. The resulting conclusions and recommendations, agreed by consensus, provide a highly credible foundation for the Commission to update and improve its approach to the management of animal welfare and ethics. Signatories to this letter consider that the Workshop's findings will be of significant value to the IWC in determining its future position and work plan on these important issues.

Importantly, the report of the Workshop presents several recommendations which, if adopted, could enable the Commission to implement a more scientific and objective approach to decision making incorporating animal welfare concerns, as is practised in many other multilateral environmental agreements. These measures, for example the introduction of an ethics review committee, would allow the Commission to more effectively address and reach agreement over divisive issues.

We encourage you to endorse the report in Jersey and to support its recommendations, in particular the formation of an ad hoc intersessional Welfare and Ethics Working Group to review the Workshop report in detail and present recommendations for action by the Commission to IWC64. In the event the Commission endorses this intersessional Working Group we also urge you to consider participating in it.

We would be pleased to hear your views on the Workshop report and recommendations prior to IWC63.
